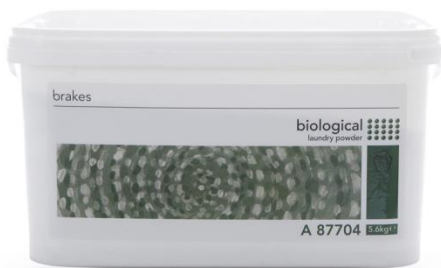

## PRODUCT GUIDANCE SHEET

### BRAKES BIOLOGICAL LAUNDRY POWDER 70 WASH

#### HOW TO USE

Add 2 scoops (1 scoop = 50g) of laundry powder to the wash powder hopper. As a guide, most domestic machines are approximately 5-6Kg.

#### CARE INSTRUCTIONS:

Always follow garment manufacturer's instructions. Do not overload the machine – if in doubt refer to machine manufacturer's guidance. Detergent is not suitable for the following categories: hand washing, pre-washing, silks, woollens and quick washes.

Do not use for the pre-treatment of stains or allow the powder to remain in contact with damp laundry before starting the wash. For best results wash at 40°C or above.

**SOAKING:** Can be used to soak articles before washing. Dissolve powder thoroughly before immersing articles.

#### Caution:

**Never soak non-colourfast or flame retardant fabrics, wool, silk, leather or items with metal fastenings. Do not use an enamel bath for soaking.**

## SAFETY ADVICE

Not classified as hazardous, however we advise that normal cleaning safety practises are adopted. Wear rubber gloves when handling and avoid contact with eyes. In case of contact with eyes, rinse immediately with plenty of water and seek medical attention if irritation persists.
