PRODUCT GUIDANCE SHEET

BRAKES FLOOR STRIPPER



A fast acting emulsion polish floor stripper, containing powerful alkalis and water soluble solvents for the effective penetration, break up and removal of the heaviest layers of floor polish. Used to remove emulsion polishes from vinyl, wood, linoleum, stone and marble, and can also be used for spray-stripping. It is an especially useful for the periodic maintenance of high traffic flooring in the hospitality, education, leisure and business sectors.

HOW TO USE

- Follow directions and dilutions correctly for the effective removal of emulsion floor polish.
- Dilute between 5 and 10:1 with warm water depending upon the amount and age of the polish build up - equivalent to 3-6 plunges of a 5lt pelican pump per litre of water in the bucket.
- Mop solution onto floor allowing 15 minutes contact time before agitating the floor with a low-speed floor machine fitted with a black or green stripping pad.
- Allow a further 10-15 minutes contact time, taking care not to allow the polish slurry to dry out.
- Remove all the slurry with a wet pick-up machine or mop.
- Finally rinse/damp mop the floor thoroughly to ensure there are no remaining residues. Allow the floor to completely dry before applying new coats of seal or polish.

Spray Stripping:

Dilute with 1 plunge of a 5lt pelican pump to a 600ml spray bottle spraying a mist over the floor a few square metres at a time, and scrub the area with a machine fitted with a stripping pad. Remove all residues and rinse floor as above.
