## PRODUCT GUIDANCE SHEET

### BRAKES DEGREASANT POWDER



A free flowing degreasing powder that has many uses within the catering department. When dissolved in warm water it produces a low foam alkaline cleaning solution that will rapidly degrease a wide variety of soils from hard surfaces. For use on floors, and most carbonised or greasy cooking utensils, baking trays and deep fat fryers.

### HOW TO USE

#### Cooking Utensils and Baking Trays:

To remove soils from cooking utensils and baking trays, immerse items for at least 10 minutes in a 0.6% solution (6g per litre) in hot water. Remove and rinse with clean water.

#### Floors, Concrete Walls, Paintwork:

Add 1 scoop of powder (1 scoop = 50g) for every 5lts of wash water. The solution should be brushed, mopped or sprayed over the surface, left for 5 minutes then washed off with clean water.

#### Deep Fat Fryers:

To boil out a deep fat fryer, drain out the oil following the manufacturer's instructions.

1. Shut the drain valve.
2. Fill with clean water to the mark.
3. Add Brakes Degreasant Powder to make a 0.6% solution or 6g per litre using the scoop provided (1 scoop = 50g).

4. Bring slowly to the boil and simmer for 5 minutes.
5. Allow the solution to cool slightly before draining out. Rinse thoroughly and ensure it is completely dry before re-filling with fresh oil.
6. Ensure the drain valve is shut before refilling with oil.
